OVERVIEW

Formerly an Assistant U.S. Attorney for the U.S. Attorney's Office of Minnesota's Civil Division, Chad was head of the Civil Fraud Unit and spearheaded the District's nationally recognized health care fraud enforcement efforts. He led nearly a hundred civil fraud investigations during his fifteen years with the office, developing expertise in the False Claims Act and Anti-Kickback statutes. Chad is one of the few attorneys nationally to successfully try multiple \$100+ million False Claims Act lawsuits to a jury.
